# What won't change?

## There are a number of services that will not change.

- Health services will continue to be delivered from all three of the main hospital sites in west Hertfordshire (Watford General Hospital, Hemel Hempstead General Hospital and St Albans City Hospital).
- Outpatient appointments, therapy services, diagnostic services and intermediate care will be provided from all three sites.
- Emergency services will continue to be provided throughout west Hertfordshire. Ambulances will take some patients to Hemel Hempstead for urgent care and the more seriously ill to Watford.

## Background

In March 2003, the consultation on "Investing In Your Health" defined the vision for local health care provision. There is growing evidence that these proposals offer better patient care and will help the NHS to address the challenging financial position in west Hertfordshire. We are now consulting on the implementation of the hospital based service proposals.

# The clinical case for change

The support for consolidating hospital services in west Hertfordshire by separating planned and emergency treatments is overwhelming and recognised as best practice.

- It is safer to have acute services on a single hospital site. Currently, clinical teams, clinical equipment and clinical back up facilities are split between different hospital sites. These services are spread too thinly as we try to provide too many services on too many sites for the resources we have. This adversely effects the quality of care we are able to offer our patients.
- Emergency care starts in the ambulance. Highly trained paramedics with extensive clinical skills now staff "blue light" ambulances and the vehicles are stocked with life saving drugs and hi-tech equipment. Today the most important thing when you are seriously ill, is that the ambulance professionals get to you as swiftly as possible and begin your treatment before taking you to the appropriate place.
- Because emergency admissions take precedence, planned operations sometimes need to be cancelled at short notice. Consolidating emergency hospital services will help reduce disruption to patients having planned care.

# The financial case for change

- In 2005/06 the West Hertfordshire Hospitals NHS Trust had a total deficit of just under £27m. The Trust's total accumulated deficit currently stands at £41m.
- We have already started to act, £15m of potential savings have been identified, but this is just the start. We need to address service duplication.
- Without achieving financial balance we will not get the new hospital the people of west Hertfordshire deserve.
