Background to the initiative

- The initiative will also enable patients to have access to standardised self-help (with the link worker)
- A directory to signpost patients to the most appropriate care will be built up
- The graduate mental health workers are not counsellors but psychology graduates who will provide low intensity CBT and anxiety management under the auspices of a clinical psychologist and the link worker
- The integrated social worker is a STAR (support time and recovery) worker. [Some link workers may also have this training.] Fair Access to Care is the legislative framework under which social care needs are assessed. There is a duty of care delegated from Adult Care Services. Eligibility is substantiated and critical care needs assessed

> The vision of the service

- Watford did **not** provide £70,000 pump-priming. St Albans did so, and this funded a full-time psychologist
- Action points
