

## **IMPORTANT CHANGES TO NHS 'RESPONSIBLE COMMISSIONER' FOR PRISONERS FROM APRIL 2003.**

From 1 April 2003, changes will be introduced to the way PCTs are funded for providing secondary care for prisoners. This is separate from but complementary to the planned future shift of funding responsibility for the totality of prison health care to the Department of Health.

These changes will apply only to England – separate discussions are being held to determine the position for Wales.

### **Current position**

At present, primary health care for prisoners is provided and paid for by the Prison Service, with the NHS taking responsibility for providing hospital and community-type services. The NHS aspect of prisoners' care is covered by the guidance on 'Establishing District of Residence' (1993), which states that the Health Authority (now PCT) responsible for funding treatment is that in which the prisoner resided before entering prison (or, if that cannot be determined, the Health Authority/PCT where the offence was committed). New guidance on 'Establishing Responsible Commissioner' will be issued by the Department shortly. We also intend to publish a separate guidance note giving more detail on the changes outlined below.

### **The changes**

Under the new arrangements, the 'responsible commissioner' for a prisoner's secondary care will normally be the PCT in which the prison is located, not the prisoner's home PCT. Resource allocations will be altered to reflect this shift in responsibility in the first instance by means of non-recurrent adjustments for 2003/4.

These changes are separate from the transfer of funding for prison health services from the Prison Service to the Department of Health that was announced by Ministers on 25 September. The NHS has always funded the hospital component of prisoner's health, and changes to 'responsible commissioner' have been in preparation for some time. However, these changes will help pave the way for consistent patterns of funding for prison health, with PCTs eventually assuming control of the entire health care budget for prisons within their boundaries.

The changes will allow for more coherent local planning of services for prisoners. Currently, as much as 90% of a prison's population can come from outside its locality, and the current funding arrangements can hamper effective provision of secondary and community type services. We already fund mental health inreach services via the PCT in which the prison is located, and this has enabled prisons and their local NHS partners to plan and implement mental health care together.

An important exception to the changes will be commissioning of secure mental health services, for which the prisoner's 'home' PCT will remain responsible. Although only a relatively small number of prisoners – around 700 – are transferred every year, the costs involved can be disproportionately high, and the associated financial risks could be difficult to manage in some PCTs with large local prison populations. Although this does slightly complicate the system, we have agreed in consultation with mental health secure commissioners that at present this is the best option.

## **Funding**

Allocations will be formally notified in the Resource Allocations Schedule published in November. We will resource the changes by levying funds across the board as a flat proportion of allocations and then reallocating them based on the number of prisoners held in prison in each PCT. We will be basing the allocations on Home Office prison population statistics, which we have also cross-checked with data we collect ourselves direct from prisons.

The allocation per prisoner is based on HCHS allocations for the 16-44 age group, minus the mental health component. Separate targeted allocations are being made as part of the Government's commitment to develop inreach services for prisoners.

We concluded that, given the profile of morbidity amongst prisoners, the overall numbers involved, and the fact that Prison Service resources in primary care are already significantly greater per capita than for the general population, as well as the decision not to 'claw back' existing funding for prisoners already in PCT baselines (see below), there has not been a strong case for further adjustments in arriving at per capita funding.

For your information, the list of prisoners per PCT is reproduced here. The list also shows the expected financial gain/loss (as a percentage of total allocations) for each PCT. It should be noted that all of the data here is subject to finalisation before the allocations are announced. The adjustment to 2003/4 baseline is non-recurrent, and this will allow us to review allocations if necessary.

## **Existing Population Baselines**

The ONS counts prisoners who have been in custody for more than 6 months as 'ordinarily resident' in the PCT where the prison is located, and allocations are made into the PCT baseline. However, this arrangement does not take account of those prisoners – over half - who receive sentences of less than 6 months, and does not fit with guidance laid down in 'Establishing District of Residence'. When deciding on the system of allocations, we concluded that it would be a fairer reflection of current practice not to adjust for existing ONS prisoner population estimates.

## **Summary**

- Before 1 April 2003, current guidelines remain in force – the prisoner's 'home' PCT remains responsible for NHS care.
- From 1 April 2003, new guidelines effective – the PCT in which the prison is located will be responsible, except for secure mental health commissioning.
- The responsible commissioner for secure mental health treatment will not change – this will remain the PCT in which the prisoner resided before entering prison.
- Funds will be levied from all PCTs as a flat percentage and then redistributed according to prisoner numbers per PCT. No adjustment will be made for prisoners already include in ONS population baselines.

- This process is separate from (although complementary to) the forthcoming transfer of Prison Service funding for health care to the Department of Health.
